Parking

- Mayors Commission unable to get a handicapped parking goal established into the planning for 2016
- LPAG Final OK to do the investigation, as results come out, will know which direction this group is heading
- Billy Goat Group Advertising in bathrooms in restaurants and bars, advertising in 23 different locations (based on our Nov vote); All locations are Denver metro;
- Citizens Service Group As a result of our signs, there were several warnings and tickets handed out 6 tickets to repeat offenders
- Coors field? Sports Authority field? No relationships, but can keep trying; Bob Epstein will try; John may have a contact at the Pepsi Center and will follow up
- o Travis County, TX (Austin) was very interested in our campaign; Constables are interested in partnering with us in the No Plates No Placard No Parking campaign
- Parking committee made a request that the CAC favorably consider using the same company that did the white paper to do outreach to municipalities with the goal of creating a list of municipalities w/contact info and rights and responsibilities, and where to call if anyone has a complaint; goal is to publish this for our constituents (website, other); second goal is to share with local and state legislators what the various sets of rules exist to show difficulty and complexity of what persons with disabilities have to deal with; Did receive a proposal which includes the state purchasing rate of up to \$10,000

Chris made a motion to authorize up to \$10,000 to Collaborative Solutions to compile the list of rights and responsibilities in various municipalities and the list of......, second by Julia. Nobody opposed, no abstentions, motion carried unanimously.

- CO Springs Billy offered to take the lead in getting signs out to businesses. Pat is also making effort. Pat will compile a list of who has been contacted and where the signs have been distributed.
- Strategies 360 (Advocacy Group, experience with public awareness and advocacy campaigns, focusing on underserved populations) presented to the group. Parking committee recommended the CAC to allow \$5,000 to interview the CAC regarding our handicapped parking campaign effectiveness.

Chris made a motion to authorize \$5,000 for Strategies 360 to do analysis and proposal for how they can assist the parking committee. Bob seconded the motion. All in favor, motion carried unanimously. The dates for the contract/mou will be determined after Gina meets with the Governor's Office on Friday, 1/15/16.

RTD Presentation

- 3 new rails lines
- Public private partnership. It's not just for medical facilities RTD has the only contract to do this

 not just building it out, but operating it for 29 years. People will not see this all trains, ect will
 have RTD logos, etc.
- A line Union station to DIA not anything to do with university of Colorado. 37 minutes end to end. Multiple parking spots along the line except at 61st and Pena. 2.00 per day after that free 24 hours. Out of RTD county coverage area is 4.00 per day.
- Gold Line Arvada Wheat Ridge 7 stops every station is a park and ride will run every 15 minutes. 25 minute trip.
- B line Union. Station to 71st and Lowell; 11 minute trip. 41 miles total but full funding is not available at this time and stops after the 1st 8 miles.
- Wider isles in the new cars, new chair options, no special loading and unloading areas for those with chairs, strollers, luggage, etc.
- There are pedestrian gates at all at grade crossings. Refuge areas between train tracks, with ground strips and gates.
- All new cars will have positive train control expensive to retrofit but we do have this since we are building from the ground up.
- Will be launching salty campaign next week. Lunched in another country and it worked very well. Will be shocking but lighthearted.

ADA Symposium

- Pat negotiated a discounted rate for us to have a table at the ADA Symposium (\$400 vs \$700) if
 we could supply some volunteers/room monitors. Gina stated that we need the registration
 form filled out with one of our invoice forms to be filled out and given to Steve Allen so that we
